

GUIDE DOGS – PAWGUST 2018 AWARDS PRIZE DRAW

TERMS AND CONDITIONS

1. As part of this, Guide Dogs SA/NT Incorporated will represent the following interested parties: Royal Guide Dogs Australia, Guide Dogs Queensland, Guide Dogs NSW/ACT, Guide Dogs Victoria, Guide Dogs Tasmania and Guide Dogs WA.
2. Entry to the Competition constitutes acceptance of these terms and conditions. All entry instructions and prize information published by the Promoter form part of these terms and conditions.
3. The Competition is only open to individuals who:
 - a. Register for PAWGUST and successfully set up a PAWGUST fundraising page via www.pawgust.com.au
 - b. Who raise funds on their PAWGUST online fundraising page
 - c. Who input their ‘PAWS stepped’ via their PAWGUST online fundraising page
 - d. Who set up teams via their PAWGUST online fundraising page
 - e. Who are not employees of the Promoter or any of its related corporations or any of their agencies associated with the Competition; (“Entrant”).
