



PAWGUST 2026 Throw Me A Bone Thursday Prize Draw – Terms & Conditions

1. Promoter

As part of this, Guide Dogs Association of SA and NT Incorporated will represent Guide Dogs organisations across Australia.

2. Promotion Period

The Competition opens at **12:01am AEST on Thursday, 13 August 2026** and closes at **11:59pm AEST on Thursday, 13 August 2026** (Promotion Period).

3. Eligibility

The Competition is open to individuals who:

- a) Are not employees of the Promoter or any of its related corporations or any of their agencies associated with the Competition; and
- b) for the Donor Prize Draw, successfully make a donation to a PAWGUST fundraising page via www.pawgust.com.au during the Entry Period; or
- c) for the Fundraiser Prize Draw, are a registered participant for PAWGUST and receive a donation on their PAWGUST online fundraising page during the promotion period.
- d) Entrants must provide their full name, mobile number and email address through the PAWGUST platform.
- e) Are 18 years old or over.
